

#### 1.4 PREMISE DETAILS

#### THE SITE


The site has an area of approximately 594,292m<sup>2</sup> which comprises of a landfill, a recycling centre and site offices. The site comprises of sealed access roads to the recycling centre and unsealed roads leading to the landfill. Trucks drive over a designated weighbridge before entering and exiting the site.

The site activities are regulated by Environmental Protection Licence #21259 (RRC) and #20814 (Landill).

#### LOCATION

#### SITE STAFF

The site employs approximately 10 staff on a full-time basis.

#### SENSITIVE RECEIVERS & NEIGHBOURING PROPERTIES

The site is surrounded by rural/agricultural land which borders the Northern, Eastern and Southern boundaries. A small section (approximately 90m) of the Blaxland Creek traverses the sites north western corner.

The Western boundary is bordered by Department of Defence land

The closest sensitive residential receivers are residential households on Bordeaux PI, Cabernet Ct and Chablis PI approximately 450m due North of the site boundary. Rural households along Luddenham Rd are approximately 600m from the site's Eastern boundary. There are no known schools, child day care centres, nursing homes or hospitals within 500m in either direction of the site.

As site business operations can change without notice, the most effective way to contact neighbouring and affected properties in the event of an incident is via a door knock at which time contact details can also be obtained for further advice when keeping affected persons informed.

Area within red dotted line below indicates location of neighbours to be notified initially via door knock following decision to notify.




NOTE: Notification area may be extended by emergency services / authorities following further assessment of risk.

### 1.8 LOCATION OF HAZARDS AND POLLUTANTS

Stormwater collected from around the site is moved through a series of storage ponds.
Stormwater is treated to meet set parameters before discharging the Blaxland Creek

Leachate is collected from around the site is pumped to this dam and stored.



A 10,000 litre self-contained self-bunded diesel fuel tank is housed next to the weighbridge.
